



# Advertising Device Control Section

## AFFIDAVIT

As an officer/owner of the organization listed below, I hereby certify the following statements to be true and accurate for the duration of the renewal period of the permit(s) listed on the enclosed invoice.

1. I have the legal right to occupy the property at the location specified in the respective permit application(s) for the erection of advertising device(s). I will advise the Ohio Department of Transportation within 15 days if the legal right to occupy any of the site(s) has been terminated within the renewal period.
2. The land owner's name and/or address have not changed during the past year. However, if the landowner's name and/or address have changed, ODOT was properly notified, and I have enclosed the updated information.
3. I adhered to all conditions of the permit application during the previous billing period.
4. I did not:
  - a. add illumination
  - b. add moving parts
  - c. enlarge
  - d. rebuild
  - e. add or change any device(s) to include device(s) changed by electronic process or remote control
  - f. replace or change structure components with unlike components
  - g. move or relocate the device(s) in any direction
  - h. remove the device(s)

Further, no other significant modifications were made during the previous renewal period to the permit(s) listed on the enclosed invoice without prior approval from the Advertising Device Control Section.

5. I have enclosed a complete list with appropriate notation(s) of any permit(s) that:
  - a. need repair
  - b. device is removed
  - c. permit plate is missing
  - d. has the wrong permit plate attached
  - e. permit plate is illegible
  - f. device is blank with no live copy
  - g. advertisement on the device is illegible
  - h. a structure only is in place
  - i. has been abandoned or discontinued
  - j. has been destroyed

I understand that correction of these sign conditions must be made within one year of renewal, and I will send a dated picture of each device subsequent to correction.

6. I am enclosing my Tax Identification Number for future references, if needed.
7. Any permit that I have noted to cancel on the enclosed list are for devices that have been removed, including all components of the supporting structure(s). I have enclosed a dated picture of the location after removal of the device(s). I agree not to erect another device at this location prior to contacting ODOT and reapplying for a legal permit.

*I understand that if any of the above statements are proven to be false or misrepresented in any way, the permit(s) may be subject to cancellation pursuant to procedures set out in the Ohio Revised Code, and the advertising device(s) ordered removed, at my expense. Further I understand that I may be subject to a monetary penalty for maintaining an illegal advertising device pursuant to 5516.99 of the Ohio Revised Code and 5501:2-2-02 (I) of the Ohio Administrative Code.*

I further acknowledge and accept responsibility for compliance with Chapter 5516 of the Ohio Revised Code and Chapter 5501:2-2 of the Ohio Administrative Code, the laws and regulations governing outdoor advertising devices.
